Financial Overview

Review of operations

- Unaudited EBITDA for the 53 week period ended 30 June 2017 was £115.5m compared to £114.2m for the audited 53 week period ended 30 December 2016.

Trading locations

- The number of funeral locations within the Dignity (2002) Group at the period end was 749, which compares to 731 at 30 December 2016. The movement in the portfolio is shown below:

2 Taxation

3 Minimum Capex Maintenance Amount

The IBLA requires the Minimum Capex Maintenance Amount rather than actual spend to be deducted in arriving at Free Cashflow.

4 Consolidated Net Assets

The consolidated net assets as at 30 December 2016 as disclosed in this Investor Report represent the final audited figures as per the 2016 statutory accounts.

Following the issuance of the Investor Report as at 30 December 2016, adjustments have been made to the balance sheet of the Dignity (2002) Group, which increased Fixed assets by £3.9m and decreased Other current assets by £3.9m. Therefore, Net liabilities as reported as at 30 December 2016 did not change from £417.6m.

These changes did not result in any changes to the financial covenants.

5 Total current assets

Total current assets include cash at bank and in hand of £7.6m (Dec 2016: £10.2m) of which £1.3m (Dec 2016: 4.5m) is cash held for operations.

6 Reserve account balances

Loan Payments Account

The balance in this account represents cash set aside to pay the future tax payments of the Dignity (2002) Group.

7 Permitted Obligor Acquisitions

The expenditure in the Relevant Period relates to the acquisition of businesses and properties other than crematoria properties and Funeral Home Start-Ups.

8 Permitted Disposals

Asset disposals by Obligors in the Relevant Period, where the market value exceeded £75,000 x CPI, comprised of one freehold properties that were not directly EBITDA generating.
